About the report

- Designed to identify economic, social, and fiscal consequences of dropping out of high school
- 5 subgroups: HS Drop-out, High School Grad, Associates Degree, B.A. Degree and Masters Degree
- Life time was established by looking at ages (18-64) and totaling working years.

Data Sources (2002/2004)

- Annual Social and Economic Supplement to the March CPS household survey used by the U.S. Census Bureau
- U.S. Census Bureau and Center for Market Studies
- Massachusetts Department of Correctional Services

High School Drop-outs will experience a wide array of adverse life experiences

- High School Drop-outs will be employed less
- High School Drop-outs receive lower hourly wages
- High School Drop-outs will earn less than better educated peers
- High School Drop-outs will payless state and federal income taxes
- High School Drop-outs will receive more in cash and in-kind services provided by the state

Fiscal Impact of Dropping-out of high school on the state of Massachusetts

Based on 2002-2004 data

A high school drop-out will receive \$5,300 more in cash and in-kind services from state and federal government agencies than he/she paid in state income or payroll taxes.

Annual Taxes Paid (Average)

- High Graduate: \$2,125
- Associate Degree: \$5,449
- Bachelors Degree: \$13,620
- Masters or higher: \$19,889

HS Graduate generates more than \$7,425 in net federal/state tax revenue

BA Degree generates more than \$19,000 in net federal/state tax revenue

Something to Think About

Nationally 7,200 drop out of school daily.

Nationally 1.3 million per year.

Dropouts are not eligible for 90% of available jobs (NPR)

\$18, 121 No HS Diploma

\$24,572 HS Diploma

\$45,678 Bachelors Degree

Added to lifetime earnings:

\$338,040 HS Diploma

\$541,040 Bachelors Degree

\$2,828,480 Doctoral Degree

Differences between the lifetime (47years) fiscal impacts of High School Drop-Outs

High School Dropouts and High School Graduates will be found to exceed: \$450,000 dollars in tax revenues

High School Drop-out and a B.A. Degree will be found to exceed: \$1,000,000 dollars in tax revenues

Dependency on Government Support

High school drop-outs are more likely to be dependent on government support in the form of cash transfers and In-Kind services.

Cost of Correctional Institutionalization in Massachusetts

Estimated cost of housing and supervising jail and prison inmates who dropped-out of high for the state of Massachusetts was estimated at \$43,025 for 2006.

The annual cost of institutionalization of male high school dropouts was two times higher than those who graduated and twenty times higher than those with a B.A. degree.

Lifetime fiscal Impacts of Drop-outs on the state of Massachusetts

Over the course of their working years a high school drop-out will create a fiscal burden to the state estimated at \$221,000 dollars

Over the course of their working years a high school graduate will contribute \$205,000 to the state in taxes

Over the course of their working years a graduate with a B.A. degree will contribute \$828,704 to the state in taxes

Fiscal revenues to the government over a life time

A High School Drop-out will cost the government an estimated \$275,000 dollars

A High School Graduate will produce a net benefit to the government approximately \$180,000

A graduate with a B.A. degree will produce a net benefit to the government approximately \$1.1 million.

High School Dropouts cost this country billions of dollars in lost taxable wages, welfare, and medical funding, and billions more for those who end up in prisons.

•4.5 Billion in lost taxable wages
