Approval of Minutes

Mayor Christenson brought forth the matter of the approval of minutes for the Regular and Executive Session. Mr. Iovino made a motion to table the minutes for the Executive Session of August 29, 2016 Mr. Leone seconded and it was so VOTED. Motions passed unanimously.

Public Comment

Mayor Christenson deferred to the audience for anyone who may have any comments.

Bonnie Page, President of the Malden Educators' Association would like to thank the school committee for voting on the Resolution to keep the cap on charter schools. Ms. Page commented that over 80 school committees have voted in support of the Resolution. She added that Malden has lost \$9 million dollars to charter schools in the city and that charter schools have had a profit of \$3 million dollars and Malden has had to make \$2.4 million in cuts to this past year's budget. Ms. Page asked for a no vote on Question 2 on November 8th.

Eden Garten-Smith 44 Greystone Road

Commented that her son's class size is 23 which she is very happy however, she feels communication to parents should be a priority when class sizes reach 25 or more students. She would like a letter to go home to parents when the classrooms reach capacity. Ms. Smith also made mention that she would like an update on testing the water in our schools for lead.

Superintendent's Report:

2. Superintendent's Report

The Superintendent announced that he will continue to meet with with parents and caretakers at Meet and Greets. Superintendent also recognized Ms. Nancy Weiss for her role as School Committee Clerk and wished her well in her new position. He also introduced Shirley Dorai as the new Executive Assistant to the Superintendent and School Committee Clerk.

Dr. Irwin Blumer was invited to speak about the work he is doing with the Superintendent. Dr. Blumer coaches the Superintendent as part of the New Superintendents Induction Program which is sponsored by the Massachusetts Association for School Superintendents and the Massachusetts Department of Elementary and Secondary Education.

A group of Salemwood School students in grades 6-8 along with Mr. Abdel Supelveda presented to the committee their experiences of Nature's Classroom. Dr. Grandson added that he will be asking students from each school to present at each school committee meeting.

3. Transportation

The Superintendent explained that he has been working with parents ensuring that they have alternatives for the children, due to the cut in the bus transportation. He added that some parents took advantage of the MBTA pass while others found alternative transportation. A parent survey was posted on our website with the solution to provide one bus for the Linden families that live more than two miles at a cost share of \$250 per family payable at the end of the month. The committee tabled the motion regarding the transportation cost and directed the superintendent to bring additional information to the next meeting Mr. Iovino made the motion and Ms. Bordonaro seconded. The vote was 6 yes - 3 no . Motion passed
