3. Ongoing Business

A. Governing Board Goals

- Kenya stated that they are not ready to be shared with the Board; she hopes to have it ready for 3/13/19 meeting
- Move to March agenda

B. Subcommittees/Procedures and Protocols:

- Title working groups as task forces instead of subcommittees, motion to move to first discussion topic within "Ongoing Business" by Deb Gesualdo seconded by John Murray
- School committee does them, this would allow work to be done sooner be, it is held to reporting but not subject to open meeting law so no need for posting meetings, must report back to GB by a set date, allows team to work immediately
- "subcommittee"=open meeting law comes into play

- Main purpose is to allow more participation from parents and staff; this would allow this to occur because of fewer restrictions.
- Kenya: uncomfortable with name change, questioning Open Meeting Laws with notes for subcommittees
- Past members made clear that this other format has failed the GB in the past and it isn't an aggressive change as we haven't used subcommittees in a long time
- Waiting for legal opinion on behalf of union and city will be coming soon on proper ways to run and treat the Governing Board
- Motion made to change our subcommittee title to task force, by Kenya Avant seconded by John Murray, all in favor-unanimous

C. Governing Board Representation (Parent Parity)

- Motion to move to second discussion topic within "Ongoing Business" by Kenya Avant, seconded by Cynara Cannatella
- discussion on moving agenda item: no
- Some research states that parent parity should be aligned with staff
- Part of legal research that we are awaiting is on comparison of Governing Board to a typical School Council, which would create more clarity of this topic as well as inclusion of past votes that should've been made by staff but were not
- Attendance policy needs to be enforced, need a solution
- Can other administration sit on Governing Board? This will be answered from legal opinion from both MTA and city lawyer.
- What are we and what laws are we held to?
- If legal opinion info doesn't get back for 3/13/19 meeting, might need to have a special meeting for these details to be discussed

D. Status of AEAP

- Jessica Leggett tried to recruit students to discuss and didn't have buy-in from kids
- John Oteri is concerned/ surprised because kids at focus groups last year were very vocal. Various kids participated, not all G/T kids. We should go to high school students and see where AEAP kids are now.
- Shared opinion of LSA being inclusive so students in younger grades could go to AEAP for one class is applicable
- Gain perspective of all schools, not just Linden
- Task force needs to get moving to can meet
- Justin Umlah can send an email out about task forces to staff. Information should also be shared through PTO, Facebook, backpacks, connect-ed,

There is a good book, Nurture Shock" that has a chapter on AEAP
