Deliberation on Employee's Child Attending Malden Public Schools - Ms. Bordonaro

Mayor Christenson invited Ms. Bordonaro to provide more details on the matter. Ms. Bordonaro thanked everyone for attending the meeting and members of the Policy and Procedures Subcommittee for their effort. Ms. Bordonaro said that the School Committee had received a letter from Ms. Colleen Kelly, a BCBA at Forestdale, requesting that her daughter, Isabella Kelly be enrolled in Kindergarten at the Forestdale School for the 2019-2020 school year. Ms. Bordonaro added that since there is no policy in place yet for admission of non-resident employees' children to the Malden Public Schools (MPS), requests will be handled on a case-by-case basis. In Ms. Colleen Kelly's case, since her husband is a police officer and in the Coast Guard, it is a challenge for them to send and pick-up Isabella from school. Ms. Bordonaro said that the Policy and Procedures Subcommittee voted unanimously to enroll Isabella Kelly in Kindergarten at the Forestdale School for the 2019-2020 school year.

In response to Mayor Christenson's question, Superintendent Oteri said that currently, there are 4 non-resident employees' children currently enrolled in MPS. Ms. Bordonaro said that the subcommittee will develop a policy and bring it to the School Committee in the fall. Ms. Bordonaro added that a hardship clause will be included in the proposed policy.

Ms. Bordonaro made the motion to approve the enrollment of Ms. Colleen Kelly's child into Kindergarten for the 2019-2020 school year. Mr. Iovino seconded. A roll call vote was taken.
