Mayor Christenson said that the salary comparisons with surrounding districts showed some districts paying higher and some paying lower. Discussion ensued about an increase within the range 2.5 - 3%.

Ms. Spadafora made a motion to approve a salary increase of 3% effective July 1, 2022 for Superintendent Noriega-Murphy. Mr. Drummey seconded. A roll call vote was taken.
