## 2. Collective Bargaining - Unit A, Unit B and Unit C

Discussion ensued about why the district is only offering 3 days of instruction instead of 5 days for students without IEPs at the Early Learning Center (ELC). The School Committee members requested more information on the number of families affected by this decision.
