# 2. Purpose 2 – To conduct strategy sessions in preparation for negotiations with Unit C because an open meeting will have a detrimental effect on the bargaining position and the chair so declares.

Attorney Greenspan said that Unit C asked about retroactive salary increases for Unit C members who completed the entire year and retired before the Memorandum of Agreement was signed. Assistant Superintendent Mertz said that at least for the past decade, employees who retire before a memorandum is signed do not receive the salary increase retroactively. Attorney

Greenspan said that the amount of money involved is minimal and not granting this request could give rise to wage complaint issues.

Mr. Iovino made a motion to approve the 3% pay increase for the 2020-2021 school year for 6 paraprofessionals from Unit C who retired this 2021-2022 school year. Mr. McCarthy seconded. A roll call vote was taken.

3. Purpose 2 – To conduct strategy sessions in preparation for negotiations with SEIU Local 888 Clerical Unit because an open meeting will have a detrimental effect on the bargaining position and the chair so declares.

Attorney Greenspan said that a counter offer was received from the SEIU Local 888 Clerical Unit and that the offer was accepted as it fell within the directions received from the School Committee at the October 4<sup>th</sup> School Committee meeting. However the Memorandum of Agreement (MOA) has not yet been ratified by the Clerical Unit as their union representative was making typographical changes to the MOA.

Attorney Greenspan continued that this two year Clerical Unit MOA would be in sync with all the other bargaining units at Malden Public Schools. The MOA stipulated a 2.5% salary increase for 2020-2021 and a 3% salary increase for 2021-2022. Other changes include a slight increase in the sick leave buyback, longevity payments, removing Step 1 Salary Level and awarding a one-time pandemic relief payment of \$1,000.

Ms. Spadafora made the motion to approve the MOA for SEIU Local 888 Clerical Unit contingent upon ratification by the union. Mr. Weldai seconded.
