2. Purpose 3 – To conduct strategy sessions in preparation for negotiations with SEIU Local 888 Custodial and Cafeteria Units because an open meeting will have a detrimental effect on the bargaining position and the chair so declares.

Attorney Greenspan presented a Memorandum of Agreement for the SEIU Local 888 Custodial Union with a three year agreement. The Memorandum of Agreement contains a COLA of 4% in 2022, 3% in 2023, and 3% in 2024 with some minor changes to longevity, added Juneteenth as a holiday and a minor change to vacation carryover. Attorney Greenspan stated that the Union had not yet ratified so the Committee should approve contingent upon Union ratification.

Ms. Spadafora made a motion to approve the Memorandum of Agreement contingent on Union ratification. Mr. Weldai seconded. A roll call vote was taken.
