1. Approval of Executive Session Minutes of September 13, 2021

2. Purpose 2 – To conduct strategy sessions in preparation for negotiations with Units A, B and C because an open meeting will have a detrimental effect on the bargaining position and the chair so declares

Due to a conflict of interest, Mr. Drummey recused himself and left the meeting.

Attorney Greenspan said that Unit C met on September 13. The proposal presented to Unit C members included a 3.5% increase for 2020-2021 with payment retroactive to September 1, 2020, a 3.5% increase for 2021-2022 with payment retroactive to September 1, 2021, a one-time

pandemic payment in the amount of \$1,000 will be made to any Unit C employee who was on the payroll as of November 1, 2020, and is still on the payroll as of the day the memorandum of agreement is signed. There were also other changes proposed for the steps and in-service credits for the 2021-2022 school year.

Mr. Iovino made a motion to ratify the Memorandum of Agreement for Unit C for the period of September 1, 2020 - August 31, 2022. Ms. Luong seconded. A roll call vote was taken.

3. Purpose 2 – To conduct strategy sessions in preparation for negotiations with SEIU Local 888 Clerical Unit because an open meeting will have a detrimental effect on the bargaining position and the chair so declares

Attorney Greenspan informed the School Committee of the salary increase of 2% for the first year and 2% for the second year as part of the initial offer along with some changes in the hours of work, bereavement days, etc. Another meeting has been scheduled for October 14, 2021. The tone was positive.

Mayor Christenson suspended the rules with the approval of the School Committee to discuss a matter brought up by a part-time employee, Ms. Lilly Sterenberg at Linden STEAM Academy regarding sick leave pay for part-time employees. On September 29th, Governor Charlie Baker signed into law an extension of the Massachusetts COVID-19 Emergency Paid Sick Leave Law. Under the law, district employees may take sick leave to address COVID-19 related health issues, receive or recover from a COVID-19 vaccination, or assist a family member dealing with COVID-19. Employees may receive up to \$850 in emergency paid sick leave benefits. Employees who work 40 hours per week, may take up to 40 hours of paid sick leave per year. Employees who work less than 40 hours per week, may take paid sick leave equal to the average number of hours per week worked over a 14-day period. Employees whose hours vary from week to week, may receive paid sick leave based on the average number of hours they were scheduled to work per week over the previous six months.

Attorney Greenspan added that this provision has been extended until April 1, 2022 or \$75 million of tax credits is exhausted by employers. Attorney Greenspan advised that the law allows close contacts to keep working as long as they test negative for 5 consecutive days. Mayor Christenson requested Superintendent Noriega-Murphy to inform all employees about the new law.

Ms. Luong made the motion to adjourn Executive Session at 8:14 p.m. Mr. McCarthy seconded. A roll call vote was taken.
